President Lisa Bieri called the meeting to order at 7:00 p.m. It was announced that the Board would be adjourning into executive session per Wis. Statutes 19.85(1)(c).

The consent agenda which included the accounts payable and financial reports, minutes from the August 19, 2021 Board meeting and executive session. Consent agenda also includes the following donations:

Board goals: No Action taken.

Motion by Mr. Kacmarynski with a second by Mr. Weidman to adopt amended COVID procedures as follows: Required masking for all 4K through 6th grade students when indoors. The exception will be physical education class in the gym (the gym allows more spacing). Optional masking for grades 7-12. Mandatory masking for all staff. For educational purposes, if a teacher is six feet or farther away from all students they may remove the mask to provide instruction. If one is alone in a room then one does not need to mask. Follow all protocols outlined in the September 1, 2021 letter to parents. Allow the use of rapid testing for COVID. Effective September 20, 2021. Volkmann – Aye, Kacmarynski – Aye, Worrick – Aye, Weidman – Aye, Todey – Nay, Zellner-Ehlers – Nay, Bieri – Nay. Motion carried.

Motion by Mr. Kacmarynski with a second by Mrs. Todey to approve retirement of Tami Desotelle as 4K teacher at the end of the 2021-2022 school year. Motion carried.

Motion by Mr. Worrick with a second by Mr. Kacmarynski to deny personnel requests to take two personal days in conjunction with the Thanksgiving holiday break. Motion carried.

Motion by Mr. Volkmann with a second by Mrs. Todey to approve requests for early graduation. Motion carried.

Motion by Mrs. Todey with a second by Mr. Weidman to approve 10 COVID sick days per person to be used for personal or family member sickness or quarantine for the 2021-2022 school year. Volkmann – Aye, Kacmarynski – Aye, Worrick – Nay, Weidman – Aye, Todey – Aye, Zellner-Ehlers – Aye, Bieri – Aye. Motion carried.
